BICYCLE RENTAL RULES OF BICYCLE RENTAL OFFICE OF THE TOWN LEVOČA

I. Opening Clause

1. Town Levoča offers the enthusiasts of cycling and hiking possibility of renting bikes for women, men and children with compulsory equipment operating in Levoča: Levoča's Information Office, Majstra Pavla 58, 054 01 Levoča (hereinafter "Town Levoča").
2. Through a leased bicycle, Levoča's visitors can discover the unspoiled landscape of Levočské vrchy, which offers true cycling experiences. A map of recommended biking trails is available for purchase at Levoča's Information Office.

II. Terms of use of bicycle and bicycle equipment

1. Renting of the bicycle and bicycle equipment is possible after the conclusion of an oral agreement for short-term rental of bicycle and bicycle equipment, which is signed by the renter with a signature on the bicycle and bicycle equipment rental Confirmation (hereinafter "Confirmation") and after submitting a valid ID card.
2. The renter must be 18 years of age or older.
3. The renter is obliged to acquaint with this "Bicycle Rental Rules of the Bicycle Rental Office of the Town Levoča (hereinafter "Bicycle Rental Rules") before renting and undertakes to comply fully with it.
4. The renter is obligated to acquaint with the technical condition of the bicycle and check the completeness of the cycling gear before taking the bicycle. For a later complaint Town Levoča will not take the notice.
5. The renter is obligated to acquaint with the terrain possibilities, for example with the selected routes in given location, with the weather conditions and its prognosis and with the technical difficulty of the selected routes before beginning of using the bicycle.
6. If the renter finds faults or any damage during using bicycle and/or bicycle equipment he/she is obliged to report them to Town Levoča after returning.
7. The renter cannot do any repairs and technological changes on the bikes and/or bike equipment without the consent of the Town Levoča.
8. The renter takes responsibility for all taken bicycles including complete cycling equipment, even for other bicycle users. Other bicycle users can only be the family members (hereafter "other bicycle users"). The renter is not bothered to leave a bicycle and bicycle gear for use by another person, except for the person/people listed in the previous sentence.

9. When cycling on the roads, every client is obliged to respect the regulations of Act No. 8/2009 Coll. on Road Traffic and Amendments of some Acts as subsequently amended, all other related generally binding regulations and traffic signs.
10. The renter or other bicycle user is required to lock the bicycle every time the bicycle is parked at the designated location, bicycle lock is included as the bicycle equipment in an order to secure the bicycle from being stolen or damaged.
11. The renter or other bicycle user:
 - must have the necessary skills and abilities to drive a bicycle,
 - while using the bicycle and/or bike equipment, it is forbidden to consume alcohol and/or use narcotic drugs and psychotropic substances.
 - user must not suffer from visual disturbances that could reasonably limit his abilities and skills to run a bicycle.

III. Bicycle equipment

1. The bicycle is equipped with compulsory equipment in accordance with the Decree of the Ministry of Transport, Posts and Telecommunications of the Slovak Republic No. 464/2009 Coll.
2. Bicycle equipment includes: front light, bicycle lock, bicycle stand, helmet.

IV. Rental payments and advance payments

1. While renting a bicycle and cycling equipment, the renter will make a refundable deposit for every rented bicycle. The amount of the deposit is 20,- €. After returning of the bicycle and cycling equipment in its original state, without any damage, the renter will be refunded in full for each rented bicycle. The deposit is returned on the basis of the submitted document from the cash register, which will be issued to the renter by Town Levoča upon deposit. Without this document the deposit will not be refunded.
2. The rental price in € for bicycle and bicycle rental is determined by the following pricelist:

3. Rent is paid by the renter in advance, when taking bicycle and bicycle equipment.
4. If the renter exceeds the rental period of the bicycle and bicycle equipment for which he/she has paid, he/she is obliged to pay the rent for the next lease period according to the applicable rate of the valid price list. Otherwise, in case the lease time is not used, Town Levoča does not return the rent to the renter.

5. The Town Levoča has the right to use a reimbursable deposit to cover the damages incurred by the renter as well as the receivables incurred to the renter in connection with the rental of bicycle and bicycle equipment.

V. Rental period

1. Lease time is for hours or days.
2. The rental period for days starts at 9:00 am of the first day and ends at 9:00 am of the last day.
3. After completing the lease term, the bicycle and bicycle equipment will be delivered to the bicycle rental office by the renter, the record will be written about this process. In case of returning a damaged bicycle and/or damaged bicycle equipment, or non-returning of a bicycle or bicycle equipment, a list of defects and damages will be written in record.
4. The lessee is obliged to return the bicycle at least 30 minutes before the end of the rental period according to point IX. When the renter fails to meet the deadline, and as is stated in the previous sentence, the renter will be charged with the next hour of renting according to the valid price list.

VI. Liability

1. Renting a bicycle is at the renter's own risk, Town Levoča does not bear any liability for damage caused by renting it on its own property or other movable and immovable objects or for damage to other persons throughout the period of lease or for the health or injury of the lessee throughout the rental period.
2. After taking the bicycle and cycling equipment, the renter takes all responsibility for the rented bicycle and bicycle equipment until returning to Town Levoča.
3. Mesto Levoča guarantees good technical condition of the bicycle.

VII. Liquidated damages

1. In case of damage, loss or theft of a rented bicycle, its parts or bicycle equipment, the renter pays the damage caused to Town Levoča.
2. If the renter returns the bike in any way of damage, this damage will be deducted from the refundable deposit. In case of damage higher than the amount of the reimbursement, the damages will be solved individually. The amount of the refund will always be determined according to the lowest possible price for repairing of the bicycle in an authorized service. When submitting a damaged bicycle or parts, the renter is required to provide complete contact/billing information for later re-invoicing of repair costs.

The cost of repairing individual bicycle damage in an authorized service is as follows:

Bike defect, exchange of the soul	4,-€
Cutting the bikes case	9,-€
Deformation of the front fork	20,-€
Deformation of front suspension fork	90,-€
Damage to rim brakes or cables	3,-€
Bike cover damage	10,-€
Damage to the bike spikes to 3 pcs	3,-€
Damage to the bike spikes from 4 to 7 pcs	6,-€
Damage to the bike spikes over 7 pcs	7,-€
Total front/rear wheel damage, sum for 1 piece	30,-€
Lighting damage to the front light / rear light, sum for 1 piece	7,-€
Loss or damage to the rack	8,-€
Damage or loss to one of the bike fenders	8,-€
Damage or loss to a seat	10,-€
Chain damage	10,-€
Destruction or loss of a lock	10,-€
Destroying or losing the key from the lock	10,-€
Loss or damage to the helmet	20,-€
Pedal loss or damage (price per piece)	5,-€
Damage to the derailleurs	12,-€
Damage to a child bike seat	15,-€
Loss of a child bike seat	35,-€
Total destruction / loss of the bicycle - according to the purchase price of a particular bicycle	€
